The 2022 Oregon Legislative Session: What is a Short Session?

The 2022 Oregon Legislative session begins February 1, 2022. This year's session is known as a "short session". In even-numbered years, the Oregon Legislature convenes in a short session that lasts a maximum of 35 days. In odd-numbered years, the legislature convenes in a "long session" that may last up to 160 days. During the long session, the legislature approves a state budget for the next biennium.

BILLS & RESOLUTIONS TO WATCH OUT **FOR**

SB 1510 Requires police officers to inform stopped persons of right to refuse consent to search, prohibits police officers from initiating traffic stops based solely on specified traffic violations, requires certain training for certification and continuing education for parole and probation officers, modifies general conditions of probation and post-prison supervision, and directs Department of Corrections to adopt rules concerning supervision reporting standards. Effective on passage.

> SB 1579 Directs Oregon Business Development Department to develop and implement Economic Equity Investment Program to award grants to organizations that provide culturally responsive services to support economic stability, self-sufficiency, wealth building and economic equity among disadvantaged individuals, families, businesses and communities in Oregon. Becomes Effective on January 1, 2023.

SB 1584 Creates procedure for filing petitions for compensation from the state for wrongful convictions. Effective on passage.

> HB 4016 Authorizes Oregon Liquor and Cannabis Commission to, based on supply of and demand for marijuana, refuse to issue initial marijuana production licenses for amount of time commission determines necessary. Becomes operative January 1, 2023. Declares emergency, effective on passage.

HB 4147 Allows persons convicted of felonies to register to vote, update voter registration, and vote in elections while incarcerated.

> HJR 205 Proposes an amendment to Oregon Constitution to specify that section restricting certain banks does not prohibit establishment of bank owned or operated by State of Oregon. A state bank could provide financial services for marijuana companies. Due to continued federal prohibition, most private lenders won't give loans or financial services to marijuana businesses. Lending intuitions who are willing to work with marijuana companies often charge outrageous interest rates and fees. A state bank ran by the State of Oregon could provide these financial services, however, passing HJR 205 only means it will become a Ballot Measure, which would need approval from voters during the 2022 election.
