### THE INTERVIEW

Here are some potential questions.

4. What sports teams do you support, and why? What sports do you like, and why?
5. If you could invite a celebrity/famous or noteworthy figure from the past or present to dinner, who would you invite, and why?

Ask at least three questions. Use any of the above, or use your own. Have fun!

It should take around 10-15 minutes for two or three people to interview each other. Take notes, because I will ask you to quickly introduce the person or persons that you interviewed to the class.
