

Law School Financial Aid Suspension – Academic Plan

You have been placed on Financial Aid Suspension because you have not maintained Financial Aid Good Standing. Financial Aid Good Standing is described as “**9 credits completed by the end of the first year, 23 credits by the end of the second year, 36 credits by the end of the third year, 50 credits completed by the end of the fourth year, 63 credits completed by the end of the fifth year, 76 credits completed by the end of the sixth year, and 90 credits completed by the end of the seventh year ; and a 2.3 cumulative GPA**”.

To retain your financial aid eligibility for the Fall 2018 semester, you must submit the following items:

- A signed letter explaining
 - The reasons you did not meet the requirements listed above AND
 - The ways you plan to improve your academic performance in the future
- Financial Aid Suspension Academic Plan

The appeal letter and this Academic Plan must be received by the Office of Financial Aid no later than June 11th, 2018. If your appeal is not received on time, your Financial Aid Suspension will remain in place until such time as you are again in Financial Aid Good Standing.
