

Financial Aid Suspension Academic Plan

You have been placed on Financial Aid Suspension, with an opportunity to appeal, because you have not met one or more of the criteria for Financial Aid Good Standing. Financial Aid Good Standing is described as **“14 credits completed by the end of the first year, 42 credits by the end of the second year, 74 credits by the end of the third year, and 106 credits completed by the end of the fourth year; a 2.0 cumulative GPA; and a 2.0 cumulative GPA in your major courses”**.

To retain your financial aid eligibility for the Spring 2023 semester, you must submit the following items:

- A signed letter explaining
 - The reasons you did not meet the requirements listed above AND
 - The ways you plan to improve your academic performance in the future
- Financial Aid Suspension Academic Plan

The letter and this academic plan must be received by the Office of Financial Aid no later than Friday, January 13, 2023. No appeals will be accepted after this date. If your appeal is not received on time or your appeal is not approved, your Financial Aid Suspension will remain in place until such time as you are again in Financial Aid Good Standing.
